Good Standing Policy

Rationale

At Wagin District High School, we believe that students have the right to learn in a welcoming, inclusive, collaborative and caring environment. The Good Standing Policy emphasises the importance of students taking responsibility for the choices they make on a daily basis, which impacts academically and socially on themselves and others.

Importance of Maintaining Good Standing & Outcome Sought

The Good Standing Policy is part of, and works in conjunction with, our whole school Positive Behaviour Support Policy. It aims to provide regular acknowledgement and recognition for the majority of students who consistently behave and act according to our school's expected values of **Engagement**, using **Manners**, displaying **Understanding** and a willingness to **Strive**.

To maintain 'Good Standing' students must comply with Wagin DHS's expectations is relation to:

- School Dress Code;
- Attendance;
- Punctuality;
- Behaviour; and
- Suspension/Withdrawal.

'Good Standing' is a status that all Wagin DHS students are granted at the beginning of each year. It is the responsibility of the student to maintain their Good Standing. Students with Good Standing are eligible to participate in events that are extra-curricular and/or where students are representing the school.

Desirable behaviours which assist students to become independent and responsible learners are listed below.

Loss of Good Standing

Students who lose their Good Standing may lose the privilege of participating in various events throughout the school year. Examples include: excursions, school camps, interschool sporting events, year-based activity days, presentation evenings or leadership opportunities such as Student Councillor.

- Students who lose their Good Standing will have a fair process to earn back their privileges. Please
 be aware that further offences that occur whilst on probation will result in the requirements
 starting over. For example, if choosing to breach the dress code policy whilst already 5 days into
 regaining Good Standing, the 10 days will recommence.
- Loss of Good Standing is actioned by the Deputy Principal or Principal. Reinstatement of Good Standing will require students to uphold the requirements of their Code of Conduct that align with Wagin DHS's expectations related to attendance, punctuality, school dress code and behaviour.
- Parents will be notified when a child is close to and/or has lost their Good Standing. During the
 period in which students can earn back their Good Standing, they may be placed on a monitoring
 card, targeting explicit behaviours that are consistent with the specific breach.
- Whilst the Good Standing Policy provides a clear guide, the Principal and Deputy Principals have the right to modify these according to the circumstances leading up to the incident or in light of a students identified needs.

Attendance

Regular school attendance is an expectation of all students and is critical in order to maximise their academic, social and emotional development. If a student is absent, an acceptable reason for their non-attendance must be provided. If an acceptable reason cannot be supplied or verified, this may impact your child's ability to participate in a Good Standing activity. Only students with Good Standing and an attendance percentage above 90% within the specific block, will be eligible to participate in the reward activities.

The following table outlines reasons why a student's Good Standing would be withdrawn and ways to earn it back.

NOTE

- Students **must maintain** Good Standing for a **minimum of 60%** of the current school year to be eligible to participate in any activity other than core curriculum.
- Students must have Good Standing at the time of the event to attend school excursions, incursions, camps, social events, interschool carnivals, Good Standing reward days and extra-curricular activities.
- Students will have access to all school based events that are part of the curriculum, regardless of Good Standing status.
- Students must maintain Good Standing to hold a Student Council position.
